MAINTAINING MINISTRY ORDINATION STATUS

Those ordained after completing one year of the ministry school will serve a two-year probationary period. After the completion of two years this probationary status will be removed.

To maintain the status as an ordained minister of the gospel the candidate commits to the following:

Agree to maintain the relationship of a committed believer as outlined above with the current local church.

Agree that the status of ordained minister changes in no way the relationship with the local church. The status of ordained minister does not confirm any authority, position of leadership, salary or title upon the candidate.

Agree not to use the status of an ordained minister within the context of the local church without the explicit permission of the churches leadership.

Agree to commit to walk in sexual purity and avoiding the appearance of impropriety in the eyes of others.

Agree to use this position as an ordained minister of the gospel to serve others and to promote the walk of Christ.

Agree to maintain integrity as regarding ministry promotion. We ask that all ministry candidates refrain for using their local church to promote their personal ministry and promote products, ministry trip and fundraising without clear written permission from the church leadership.

Agree not to promote their personal ministry or hold any meetings/events within a radius of 15 miles without the express written permission of their local church leadership.

Agree to refrain from seeking to promote their ministry by using the mailing lists, church directories or publicized itinerary of other ordain ministers.

Agree to conduct themselves in a way that promotes unity, peace and harmony in the body of Christ. Agree to walk in biblical financial integrity and compliance with the laws in precepts of the country of residence.

REMOVAL OF ORDINATION STATUS

If the candidate fails to maintain the standards outlined as part of the ministry school ordination process we reserve the right to remove the status as an ordained minister of the gospel. Before taking this step the candidate would be informed (in person and in writing) of the areas of difficulty and given a window of opportunity to correct this behavior.

If the candidates status is an ordained minister needs to be removed because of sin or a clear lack of biblical integrity we reserve the right [and duty] to inform other churches and ministries as necessary that we no longer recognize this person's status in regards to ordination.
